

Budget 2025: Key announcements for Family Carers

"Carers play a fundamental role in our society, and Government is committed to supporting individuals and families with caring responsibilities." Minister Jack Chambers

 €12 increase in all weekly social welfare payments including Carer's Allowance and Carer's Benefit; There will be proportionate increases for qualified adults and people getting a reduced rate; DCA to be increased by €20 (From January 2025)
 Increase in Carer's Allowance income disregard for means test from €450 to €625 per week for a single person and from €900 to €1,250 per week for a couple (From July 2025)
 Increase in the Carers Support Grant from €1,850 to €2,000 (Paid annually in June)
 Carer's Benefit extended to self-employed workers (From January 2025)
 Double week Cost of Living bonus to pensioners, carers, lone parents, people on disability payment and long-term jobseeker recipient (October 2024)
 Once off payments : €400 for recipients of Carer's Support Grant, Disability Allowance, Blind Pension, Invalidity Pension and Domiciliary Care Allowance (only payable in respect of one payment, even if you qualify for more than one of these payments or are caring for more than one person); €200 Living Alone Allowance; €300 Fuel Allowance; €400 Working Family Payment; €100 Child Support Payment for each qualified child - (All paid in November 2024)
 Christmas Bonus for all long-term social welfare recipients to be paid in December 2024, including those on Carer's Allowance, Carer's Benefit and Domiciliary Care Allowance (December 2024)
• Two Child Benefit payment (Paid in November and December 2024)
 Qualified Child Payment to be renamed as the Child Support Payment – weekly payments will for under 12s will increase by €4 to €50 and by €8 to €62 for over 12s (From January 2025)
 Two €125 energy credits before and Christmas
 Maternity Benefit, Paternity Benefit, Adoptive Benefit and Parent's Benefit increased by €15 to €289 per week (From January 2025)

	 €60 increase in the income thresholds for the Working Family payment regardless of family size (From January 2025)
	 Means test disregard for Fuel Allowance extended to those aged 66 and over - €524 (single person) and €1,048 (couple) (From January 2025)
	 Carer's Allowance to become eligible payment for Fuel Allowance (From January 2025, if you meet all eligibility criteria)
	• Auto Enrolment will start 30 th September 2025
	 Increase in the disregard for Sale of Residence where a person enters care from €190,500 to €337,500 (for State Pension Non- Contributory/Disability Allowance and Blind Pension).

	 One-year Mortgage Interest Relief Scheme to be extended by one year
	 CAT increase to €400,000 for Group A threshold; Group B increasing from €32,500 to €40,000; Group C threshold increasing from €16,250 to €20,000 (2025)

¹ In July 2024, the government extended the Free Travel Scheme to people aged over 17 and under 66 and; have never been able to drive due to a disability; have been medically certified as 'not fit to drive' for at least 12 months.
